EOS at Federated Hermes

Mineworkers' Pension Scheme

Over the last quarter we made voting recommendations at 745 meetings (10,226 resolutions). At 481 meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at 44 meetings and abstaining at three meetings. We supported management on all resolutions at the remaining 217 meetings.

Global

We made voting recommendations at 745 meetings (10,226 resolutions) over the last quarter.

- Meetings abstained 0.4%
- Meetings with management by exception 5.9%

Australia & New Zealand

We made voting recommendations at three meetings (14 resolutions) over the last quarter.



- Total meetings in favour 33.3%
- Meetings against (or against AND abstain) 33.3%
- Meetings with management by exception 33.3%

Developed Asia

We made voting recommendations at 155 meetings (1,690 resolutions) over the last quarter.



- Total meetings in favour 43.9%
- Meetings against (or against AND abstain) 53.5%
- Meetings with management by exception 2.6%

Emerging & Developing Markets

We made voting recommendations at 268 meetings (3,187 resolutions) over the last quarter.



- Total meetings in favour 36.9%
- Meetings against (or against AND abstain) 61.6%
- Meetings abstained 0.7%
- Meetings with management by exception 0.7%

Europe

We made voting recommendations at 124 meetings (2,417 resolutions) over the last quarter.



- Total meetings in favour
- Meetings against (or against AND abstain) 75.8%
 Meetings abstained 0.8%
- Meetings with management by exception 4.8%

North America

We made voting recommendations at 165 meetings (2,238 resolutions) over the last quarter.



- Total meetings in favour 9.7%
- Meetings against (or against AND abstain) 75.2%
 - Meetings with management by exception 15.2%

United Kingdom

We made voting recommendations at 30 meetings (680 resolutions) over the last quarter.



- Total meetings in favour
- Meetings against (or against AND abstain) 46.7%
- Meetings with management by exception 20.0%
